**ADVERTISEMENT FOR BIDS FOR CONSTRUCTION OF  
SEWERAGE SYSTEM IMPROVEMENTS  
for the  
CITY OF MILLEDGEVILLE, GEORGIA**

Sealed proposals will be received by CITY OF MILLEDGEVILLE, GEORGIA at City Hall, P.O. Box 1900 or 119 E. Hancock Street, Milledgeville, Georgia 31061 (only shipping packages are received at street address) until 3:00 P.M. local time, Thursday, August 9, 2018 at which time and place they will be publicly opened and read. No submitted bid may be withdrawn after the scheduled closing time for receipt of bids for a period of sixty (60) days.

All Bidders must have a State of Georgia Utility Contractors License and must employ a state "Utility Manager" certificate holder who will have oversight of all the work.

Work to be done: The work to be done consists of furnishing all materials, equipment and labor for the construction of:

Installation of 650 L.F. of 8-inch sewer line and two manholes, rehabilitation of 3,100 L.F. of 8-inch sanitary sewer using trenchless pipe replacement, including cleaning, pre and post video, replacement of 21 existing manholes, dig and replace 55 service connections, by-pass pumping, and appurtenances. Time allotted for construction is 180 consecutive calendar days.

Proposals for the complete work in one general contract shall be made on the proposal form provided and shall contain prices in words and figures for the work bid on.

This project is funded by a Community Development Block Grant. This is a Section 3 Covered Project under the HUD Act of 1968 and Section 3 Residents and Business Concerns are encouraged to apply. A *PRE-BID MEETING* will be held on *JULY 26, 2018 at 10:00 A.M.* in which Section 3 preferences and compliance will be discussed in detail. Bidders are encouraged to attend, but attendance is not mandatory in order to submit a bid. The meeting will be held at City Hall.

The City of Milledgeville, Georgia is committed to providing all persons with equal access to its services, programs, activities, education, and employment regardless of race, color, national origin, religion, sex, familial status, disability or age.

All proposals shall be accompanied by a Bid Bond drawn in favor of City of Milledgeville, Georgia, in the amount of at least ten percent (10%) of the lump sum bid for the complete work; such Bid Bond representing that the Bidder, if awarded the contract, will promptly enter into a contract and furnish Performance Bond and Payment Bond as provided by law and approved by the Attorney for City of Milledgeville, Georgia. Each bond shall be equal to one hundred percent (100%) of the contract amount. The Bid Bond shall be forfeited to City of Milledgeville, Georgia as liquidated damages if the Bidder fails to execute the contract and provide

Performance and Payment Bonds within ten (10) days after being notified that he has been awarded the contract.

Drawings and Specifications are open to public inspection at the office of the City of Milledgeville, at the office of Turnipseed Engineers, in Augusta and Atlanta, Georgia and the AGC Builders Exchange in Smyrna, Georgia.
