Questions or requests for interpretations shall be in accordance with instructions to bidders and must be received at least 6 business days prior to bid opening.

The Disadvantaged Business Enterprise (DBE) goal for this project is 15%. The completed DBE Goals Form, Federal Aid Certification and Georgia Security and Immigration Compliance Act Affidavit (included in Appendix A) must be submitted with Bid. Small and other disadvantaged businesses requiring assistance with the competitive process can contact the GDOT SSFP Business Help Center at One West Court Square, Regus Center – Suite 750,

The Georgia Department of Transportation (GDOT) Standard Specifications for Construction of Transportation Systems, 2013 Edition; Supplemental Specification Book, 2016 Edition; and applicable Supplemental Specifications provided herein, apply to the contract. The applicable GDOT specifications govern over any conflicting requirement that may be found in the Agreement, Supplemental General Provisions and General Conditions.

The focus of the project is the removal and replacement of existing concrete sidewalk running parallel to a length of Greene, Wilkinson, and McIntosh Streets with new brick-banded concrete walkways to update the area and give it a modern aesthetic. In addition, concrete and asphalt driveways will be replaced as well as new landscaping, electrical, and lighting introduced to the area. Roadway striping along parking spaces will be re-painted and several new storm sewer structures introduced. Finally, a concrete retaining wall and stairwell will be constructed on the south side of McIntosh Street near its intersection with Wayne Street.

The project is expected to be complete within 180 calendar days.

A bid bond and performance and payment bond will be required. The Bid Bond will be 10% of the contract amount; Performance Bond will be 100% of the contract amount and a payment bond of 110% of the contract.

Bidders submitting bids over \$2,000,000 shall be prequalified with the GDOT.

Bidders submitting bids \$2,000,000 or less shall be prequalified or registered subcontractors with the GDOT.

The owner reserves the right to waive any informality in bidding and to reject any or all bids.
